I agree to take full responsibility for my persons, animals, property, and merchandise. I will not hold Furry Friends Network **OR** Stumpf Field, LLC, and it s affiliates responsible for any loss, damage, or injury to my/or by my persons, animals, property, or merchandise. I understand that the sale of food*, firearms, martial art weapons, ammunition, knives, alcoholic beverages, and pornographic material is strictly prohibited. I am aware that Furry Friends Network event coordinators have the right to inspect the safety of my booth, approve or disapprove products being sold, and may dismiss me at their sole discretion. (*Pre-packaged food & drinks are permitted. i.e. chips, soda, water, candy, etc. **NO HOMEMADE ITEMS** are permitted).

I/We also understand if my organization chooses to have pets present that:

- 1) All dogs and cats must be under control, meaning but not limited to, being kept on a leash with one dog/cat per handler, if not on a leash they must be confined within a cage or crate.
- 2) When pets are on leashes they must abide by the posted 3-FOOT RULE, meaning but not limited to, remaining 3 feet away from all other animals at all times.
- 3) Our organization is responsible for cleaning up after the pets in our care.
- 4) We understand the risks of exposing animals to extreme heat, and other animals. I plan to take necessary precautions for the safety of my pets in my care such as providing them with proper ventilation, sufficient water, and a safe distance from other animals.
- 5) It is mandatory that all pets present have current vaccines and be free and clear of any contagious illnesses.
